*My name is John Smith and I am a professional security operative in Murphy's Supermarket in Eyre Square, Galway. On Monday 5th October 2015 at approximately 10:47 I was on duty. I was positioned in the CCTV room at this time and I was operating the store CCTV system.*

*I observed on CCTV a male and a female enter the store. I would describe the male (MALE 1) as; IC1, aged between 30 and 35 years old, medium build, approximately 5 feet 9 inches tall with brown hair. He was wearing dark jeans, a blue shirt and carried a white bag over his shoulder. He appeared to be accompanied by a female wearing a white dress. I observed MALE 1 walk into the area containing alcohol products. This aisle is covered by camera 6 on the CCTV system. I watched MALE 1 select 3 items from the shelf and conceal them inside his bag. The female appeared to mask the MALE 1 from the cashier's view while he concealed the items. The group then left the store with MALE 1 making no attempt to pay for the items.*

*I called for support on the radio from my security colleague Tom Kelly as they left the store and we followed the group outside. I approached MALE 1 outside of the store and identified myself as security. I spoke to him as follows "I am the security operative from Murphy's Supermarket. I am arresting you for theft. Please return to the store with me". The female left in the direction of Bridge street as I had not witnessed her commit any arrestable offence.*

*MALE 1 returned to the store security office with Tom Kelly and I. The female returned the 3 items of baby he had concealed. They were 3 bottles of POWERS whiskey which had a value of €60.00. I contacted the Gardai at 10.55. While waiting for Gardai I asked MALE 1 for his personal details. MALE 1 identified himself to me as Barry Moran of 32 The Orchard, Galway City and gave his date of birth as 10th August 1983. These details were recorded in my notebook at this time.*

*Garda Seamus Mullen (GA234) arrived at the store at 11:40. I informed him of what I had observed and my actions in arresting MALE 1. Garda Mullen then removed the male from the store. I informed Joe Murphy (Store Manager) of the incident and returned to the CCTV room to complete my duties.*
